## **HUMANE SOCIETY AGREEMENT**

A specification sheet outlining detailed technical and performance information on the proposed purchase of a backhoe was provided to Manger Stambaugh by Public Works employee Brian Rotolo. Mr. Rotolo took the lead and was the primary person overseeing the project.

President Bloss indicated the general consensus of Council was to table action on the Humane Society contract until the December 17, 2024, Regular Business Meeting.

# DEPARTMENT OF COMMUNITY AND ECONOMIC DEVELOPMENT GRANT BACKHOE PURHCASE

Manager Stambaugh stated the backhoe in question came in at a list price of \$220,746.00. Through the Commonwealth of Pennsylvania's cooperate purchasing program (COSTARS), the price came in at \$144,850.00. If Penbrook Borough had continued with their original decision to enter a joint purchase with Paxtang Borough, there would have been a projected \$20,000.00 trade-in allowance on the Penbrook backhoe leaving a Statewide Local Share Assessment Grant of \$124,850.00. By Penbrook changing their original plan for using the trade-in on a joint grant, and instead choosing to use it on a separate grant, Paxtang will now be the sole owner of the backhoe at a cost of \$20,000.00 (Twenty Thousand Dollars).

Manager Stambaugh proceeded to present the report as submitted by Public Works Employee Brian Rotolo highlighting features and multiple ways the backhoe would be beneficial in their day-to-day operations. Discussion was held to possibly finance the backhoe for 2 years through a split from the Sewer Fund, Capital Reserve Highway Fund, and General Fund. A portion of the costs would fall under Stormwater but since Paxtang Borough does not have a stormwater fee in a separate fund, funding would be made from the General Fund.

\*1) Vice-President Fillman made a motion to move forward with the purchase of the backhoe, anticipating costs up to and including approximately \$20,00.00. Motion seconded by Councilman Bower. Vice-President Fillman stated he spoke with Brian Rotolo, was disappointed the partnership with the neighboring jurisdiction fell through but was pleased that the opportunity would now afford full ownership by Paxtang Borough. Vice-President Fillman expressed his gratitude to Mr. Rotolo and Manager Stambaugh for the positive way they thought this through and stated he was in favor of the purchase.

President Bloss said while costs will be incurred, Public Works employees will have 100 percent use and control of the backhoe on their own timeline with the ability to tend to any needs on an immediate basis. Motion carried after commentaries.

## REQUEST FOR USE OF MUNICIPAL GYM - PAXTANG ART ASSOCIATION

\*2) Councilman Thomas made a motion to approve gratis use of the municipal gymnasium by the Paxtang Art Association for the dates and times as requested. Motion seconded by Councilman Bower. Motion carried after a brief discussion that the Art Association would make schedule changes if work around any possible scheduled repairs to the gymnasium floor.
